- Below is our PCSA tryout policy and the current Spring 2024-25 tryout dates.
  - o PIERCE COUNTY SOCCER ASSOCIATION TRYOUT POLICY:
    - As soon as an RCL club holds tryouts, the earliest any other club in the association can hold Select/Competitive tryouts, will be 72 hours starting Day 1 of the RCL tryouts. The primary driver of this decision/agreement was to ensure a player was not left behind by not having a team to return to or option to play for another club. If a player tries out for an RCL team/club and does not get selected or agree with the roster spot offered, the player now has options to go to tryouts at their existing club or any other club with a select program.
