Treasurer :: Cheryl Mercuri meeting planner and report via email sent 9/18/24

- This past weekend I sent out invoices to the clubs, each club should have received 2 invoices.
  - First one was for the player fees for the 2023-2024 season for the period 10/1 and after
  - Second invoice was for the player fees for the Fall 2024-2025 season for the period 01/01/24 through 6/30/2024. I included a link in the email to a google document that has all the supporting documentation broken out by club. This invoice also included a net player number for the PCSA player fee
- Next Invoice will come sometime in October and will cover the period 07/01/2024 to 09/30/2024. The new fees really increased the invoice amount the amount in the queue for July and August is in excess of \$40K, there will be one last invoice that will come in the spring of 2025 and cover player 10/1 and after.

- Washington Youth Soccer is conducting a risk management audit. See below for details. All club registrars received notification from me to include directions for how to run a report to see who, if anyone, is out of compliance within their clubs.

- As part of ongoing efforts to ensure compliance and safety, WYS is planning a risk management audit for all Board Members, Club Staff, and Team Staff to verify that participants have met the required standards. Current requirements include:
  - · 1. Safe Sport Training Federal Law
  - 2. Intro Into Safety US Soccer Washington State Law (Concussion and Sudden Cardiac Arrest)
  - · 3. Social Security Background Check US Soccer requires that background checks include each applicant's Social Security Number. This meets industry standards and ensures that the findings are accurate.
- During this audit, WYS staff will be reviewing the accounts of admins with a current application.
  They will check to ensure all requirements are current and up to date. To perform this audit, we will be pulling a report from the Sports Connect State Platform

# WYS will be looking for:

- Expired verifications
- Verifications verified by manual uploads
- Risk status of the admin

If any discrepancies are found, the Association and Club Registrars will receive a list of the admins with issues in their accounts. Any issues will result in the admin being placed in a risk status of "Hold and Release." This status will restrict their ability to review their assigned team, print match day reports, and access digital player cards. If the issue is not resolved within two weeks of receiving notification, the admin's application will be canceled, and they will be removed from the team. **Once an issue is resolved, it will be the responsibility of the registrar to notify WYS to update the account.** 

The audit will commence on September 1, 2024, and may last for a month or more. Please see a full timeline below.

### WYS 2024 Risk Management Audit Timeline

- 8/9 Audit announcement
- 8/9 to 8/30 Association / Club admin internal review and updates for compliance
- 9/1 WYS audit begins on a rolling basis, including:
  - We will be starting in District 1
  - o Reports will be shared with Association / Club admins
  - o Participants found not compliant placed on "Hold & Release" status
    - Two-week window for compliance starts when WYS shares reports
- 9/15 Participant application cancellations and removal begins:
  - o Timing will vary based on rolling start dates
